

Bainbridge Community Pool and Playground Rules
Hours of Operation: 9:00 a.m. – 8:00 p.m.
Bainbridge Homeowners and Guest only!
THE POOL IS CLOSED EVERY MONDAY FOR CLEANING!!!

1. SWIM and PLAY AT YOUR OWN RISK! No lifeguards are on duty! Members and their guests enter the pool and playground area and use the pool at their own risk!
2. NO HORSEPLAY AT THE POOL AT ANY TIME!
3. The pool and playground are for the exclusive use of Bainbridge members and their guest. No more than two guests per household are allowed at the pool at a time. Bainbridge property owners must be present with guests at all times.
4. **NO ONE UNDER THE AGE OF 18 IS ALLOWED IN THE POOL OR POOL AREA WITHOUT AN ADULT (18 YEARS OF AGE AND OLDER).**
5. No person who has open sores, any communicable disease or health problem that could endanger other may enter the pool.
6. Pool hours are Tuesday-Sunday 9:00 a.m. to 8:00 p.m. and closed on Mondays for maintenance and cleaning. Swimming and/or access to the pool area is prohibited after hours. Playground hours are Monday-Sunday 9:00 a.m. to 8:00 p.m. Anyone found in the pool and playground areas after hours will be reported for trespassing to the Madison County Sheriff's Department.
7. Be considerate of other pool and playground users. Please no loud, obnoxious behavior or music, no excessive affection and no profanity.
8. Any damage to pool and playground areas or surrounding area will be the responsibility of the member causing the damage or the member hosting the guest who caused the damage.
9. Pool gate must be closed upon entering and leaving the pool, and no one may open the gate for another person that does not have their fob.
10. Proper swimming attire is required. No cutoffs permitted. All infants and toddlers must wear proper "swim diaper" in pool.
11. An adult must accompany children under the age of 10 to the bathrooms. Urinating in the pool and/or pool area is strongly prohibited.
12. Pets are prohibited from the pool and playground area.
13. Excessive use of sun tanning oil is prohibited upon entering pool.
14. NO SMOKING or tobacco products in the pool area.
15. Glass bottles, jars and/or containers are prohibited in the pool and playground area.
16. No use of grills in or around the pool area.
17. All trash MUST be placed in the trash receptacle before leaving.
18. Any persons under 21 years of age found consuming alcoholic beverages will be reported to the Madison County Sheriff's Department.
19. Please be considerate of others when using the pool and the restroom. We are all members of the Bainbridge Owners Association and our dues are spent on maintaining our common facilities.
20. There is a \$50.00 (fifty) fee for all replacement fobs. One fob per household will be/has been given free of charge to all homeowners that are CURRENT on their HOA assessments. 21. You are responsible for your fob. You are not to give your fob to anyone outside of your home. NO EXCEPTIONS.
